Subject:- **GRANT OF FOUR MONTH SALARY TO THE FAMILY OF DECEASED CIVIL SERVANTS.**

Kindly refer to Govt. letter No. SO(Pension)9-11/2018 dated 30-04-2019, on the subject cited above.

It has generally been observed by the Govt. that the cases of family pension and grant of four months salary to the family of deceased Govt. servants are being in-ordinarily delayed on one pretext or the other. The competent authority has shown serve concern over delayed submission of grant of four months salary cases of the bereaved family of deceased civil servants.


This state of affair is quite miserable on the part of the controlling officers i.e. Headmasters, Dy.District Education Officers, District Education Officers and Chief Executive Officers (DEA) offices which needs to be addressed on emergent basis. It has also been observed that family members of the deceased civil servants, in the first instance, do not know what kind of financial benefits have to be paid to the deceased family for which they have to pay frequent visits in offices in order to get their legitimate benefits from the Govt. Mostly, their cases remain pending for months without giving special attention to them.

Competent has desired that in future, if any of the aggrieved family of deceased civil servant is found victim of inordinate delay beyond 90 days of the obituary notification, in finalization of four month salary and other peripheral financial incentives, the concerned controlling officer will be held responsible. Prompt action is desired from each office in order to dispose of such cases expeditiously.
