### TERMS AND CONDITIONS

1. The promotees shall have to join their new place of posting within fifteen days of the issuance of this order, otherwise it will be presumed that they are not willing to avail promotion as SST and their promotion shall be treated as cancelled/withdrawn automatically.
2. The validity of promotion and release of salaries of the above promotees is subject to the verification of service record, degrees from the recognized concerned institutions/Education Board/Universities etc. The concerned controlling authority/joining authority and DDOs are personally responsible for this purpose. If the service record, degrees and certificates are found bogus or 3<sup>rd</sup> division in Master Degree and professional degree, the promotion of individual posting will be considered as withdrawn/cancelled by the DRC as well as by the appointing authority.
3. The promotion will be probation for the period of one year and further continuance shall be subject to satisfactory completion of probation period.
4. All the above promotions are made on purely temporary basis till the successful completion of probation and are liable to be terminated at any time without assigning reason/notice. In case they wish resign any time, one month notice will be necessary or one month pay in lieu thereof before resignation to be surrendered.
5. They will join at their new place of posting at their own expenses/TA.DA not allowed.
6. In case of any appeal and its decision on merit, the promotion of any of the above mention candidate may be cancelled and he can be reverted to his previous post. In such promotion cases the affectee shall have no right to challenge the same before any court of law. Similar condition will apply in case any of academic/professional certificate/degree of any of above appointee is declared bogus by the concerned issuing Board/University, then he shall be reverted back to his/her original post besides taking disciplinary action by the authority.
