

2. Such practice is the violation of the Notification No. SO(A-I)-1-31/2008 dated 13-12-2019 issued by Government of the Punjab ,School Education Department. Lahore as well as Section 12-C of the Punjab Private Educational Institutions (promotion and Regulation) Ordinance 1984(Ordinance IV of 1984) amended act, 2017. www.786Times.com

NOW THEREFORE in exercise of the powers conferred upon me as "Registering Authority" and as prescribed in Punjab Educational Institutions Promotion and Regulation Ordinance 1984 amended 2017 under section 11 (4) you are hereby directed to appear before the undersigned on **31-12-2019 at 11:00 AM** along-with your written reply regarding above noted allegations/charges. In case of non- compliance from your side, penalties may be imposed upon you under the Punjab Private Educational Institutions (Promotion and Regulation) Ordinance, 1984 amended (2017) i.e. Fine or Cancellation of Registration / Sealed the Institution. You are also directed to bring the copy of Registration Certificate along-with you.
